Implementation of this MOAA will assist in delivering the following outcomes for the delivery of evidence-informed alcohol and other drug treatment and intervention services in South Australia

- Agreed, joint needs assessments that inform and guide the commissioning decisions of all parties
- Complementary commissioning processes based on this needs assessment enabling the most efficient allocation of resources based on need and reducing the likelihood of duplication of effort or resource allocation.
- Planning and commissioning processes that clearly reflect the South Australian context, building on identified opportunities and reducing risks.
- Information collation and sharing (as appropriate) that:
- Provides timely advice to each party to inform their commissioning and funding decisions; and,
- Enables the monitoring of the service system as a whole to identify areas of demand or need.
- Development of the evidence-base to inform future decisions and identify priorities for potential new investment (subject to new funding opportunities);
- Improved treatment pathways between primary health services (e.g. general practitioners) and alcohol and other drug treatment service providers; and
- Measurable strategies across commissioned services to benchmark progression of sector integration.
